I. CALL TO ORDER

III. SPECIAL DRAINAGE DISCUSSION

Chris Morton gave a recap regarding the drainage committee's discussion with fellow BOD members following the March meeting because a consensus was not reached during the meeting. There was also an onsite orientation over the weekend to discuss specifics about the three bids regarding BISCAYNE BLVD CULVERT AND EASEMENT and VANDIVERE EASEMENT AND CULVERT.

- A. Chairman discussed the three bids and the preferred bid (Aitkens On Demand) recommended by the drainage committee. The committee stated the bid was the most complete and addressed the specific level of work requested from the committee. Thus, in spite of being the highest bid, it provided the best value in terms of the complete scope of work and accountability.
- B. Chairman stated Emerald Coast Lawns bid did not provide the level of work needed, primarily on Biscayne Blvd. The Quad-State Cutters bid did not address culverts.
- C. Chairman then asked if anyone in attendance had any specific questions or concerns about the three bids proposed for easement and culvert clean-up.
 - a. No specific questions were asked from the members present.
- D. With no questions brought forward, Fred motioned to approve the AITKEN'S ONDEMAND Landscape and Irrigation, LLC estimate #4875, Josh Huston seconded the motion and all 6 BOD members voted aye, motion was carried.
 - a. Project will likely not be started for three weeks or more from contractor.
- E. Board president discussed notifying EPM about violation enforcement after the work is completed, so we do not end up in this situation of overgrowth again.
- F. Discussion on records management between Fred and Sharie took place and community members were shown where and how to access records online.
